In 1905 and 1906 he served in the State Legislature and his record there is one of the bright spots of that session. He introduced and through tireless effort succeeded in passing the bill known as the "EDLIS ACT," the first WHITE SLAVE legislation enacted in the United States. The effect of this act in the State of Pennsylvania was tremendous and far reaching and was instrumental in elevating the moral conditions of the county.

In 1909 he was appointed Treasurer of the City of Pittsburgh by William A. Magee, being Mayor of the City at that time. He served as Treasurer of the City until 1914. During his administration in this capacity many reforms were instituted

by him resulting in completely revolutionizing the affairs of that office. Unnecessary positions were abolished. The new Pre-Billing System for the collection of taxes was installed which was so successful in saving the tax payers money and time that it has been adapted in the

County Treasurers office. Mr. Edlis made it possible through his persistent demands upon Council to have the banks holding city funds pay the maximum amount of interest thereon and also increased the number of city depositories, thus giving all the banks an equal opportunity in the

handling of the city funds. All this resulted in the financial benefit of the city, increased the efficiency of the office, saved tax payers thousands of dollars which previously had been wasted.

While City Treasurer Mr. Edlis abolished the Delinquent Tax Office claiming that the City Treasurer should collect all the delinquent taxes and that there was no necessity of maintaining a tremendously expensive office for that purpose.

The City Treasurer today collects the delinquent taxes at practically no additional expense to the people, so Mr. Edlis' position has been entirely vindicated.

If you will elect Mr. Edlis as County Treasurer he will be free to perform his official duties precisely as he did when City Treasurer.
